Constitution of Ethical Compliance Committee

Career Point University has constituted an **Ethical Compliance Committee (ECC)** to address complex ethical issues that may arise in academic, research, and administrative activities of the University. The Committee provides a structured and impartial platform for ethical review and deliberation, ensuring that institutional decisions and actions align with established moral, legal, and professional standards.

The Ethical Compliance Committee plays an important role in maintaining institutional integrity and safeguarding the interests of various stakeholders, including students, faculty, staff, scholars, and the wider community. Its establishment reflects the University's recognition that modern academic and institutional environments often encounter situations where different values and responsibilities may conflict, and therefore require careful ethical evaluation and guidance.

Composition of the Committee

The Committee looks at policy issues, reports on compliance with ethical standards, and deals with issues of misconduct or non-compliance. It puts forth recommendations which improve institutional processes, runs ethical awareness programs, and sees to it that all issues are dealt with in a fair, confidential and due diligence manner.

All Committee sessions are to be kept confidential. Members are expected to act with honesty, with no bias, and with responsible judgement. Their actions should be in line with the University's code of ethics and should safeguard the interests of the stakeholders.

The tenure of the Chairperson and members of the Committee shall be **three years from the date of the constitution of the Committee.**
